#### LOCAL LAW NO. 1 OF THE YEAR 2023

(Introduced as Introductory Local Law No. 8 of the Year 2022)

### A LOCAL LAW REPEALING THE MORATORIUM ON THE FILING, ACCEPTANCE, REVIEW, OR DETERMINATION OF ANY LAND USE APPLICATION PERTAINING TO TWO-FAMILY DWELLINGS AND MULTIFAMILY DWELLINGS IN THE TOWN OF BRUNSWICK

#### Section 1. Title.

This Local Law shall hereafter be known as the "Local Law Repealing the Moratorium on the Filing, Acceptance, Review, or Determination of Any Land Use Application Pertaining to Two-Family Dwellings and Multifamily Dwellings in the Town of Brunswick."

#### Section 2. Legislative Findings and Intent.

The Town Board of the Town of Brunswick finds that since the Board has adopted a Local Law with specific amendments to the two-family and multifamily dwelling provisions of the Brunswick Zoning Law, which were contemplated by the adoption of the moratorium pertaining to two-family and multifamily dwellings, such moratorium is no longer pertinent or necessary and should accordingly be repealed.

#### Section 3. Repealer.

This Local Law shall repeal Local Law No. 2 of 2021 "A Local Law Establishing a Moratorium on the Filing, Acceptance, Review, or Determination of Any Land Use Application Pertaining to Two-Family Dwellings and Multifamily Dwellings in the Town of Brunswick", as extended by Local Law No. 3 of 2021, as further extended by Local Law No. 4 of 2022, and as further extended by Local Law No. 7 of 2022.

#### Section 4. Severability.

If any section or subdivision, paragraph, clause, or phrase of this local law shall be adjudged invalid or held unconstitutional by any court of competent jurisdiction, any judgment made thereby shall not affect the validity of this law as a whole or any part thereof other than the part or provision so adjudged to be invalid or unconstitutional.

#### Section 5. Effective Date.

This local law shall take effect immediately upon filing with the Secretary of State of the State of New York.
