**RESOLUTION OF THE TOWN OF BRUNSWICK DECLARING NEED AND  
AUTHORIZING THE APPLICATION FOR A MUNICIPAL OPERATING  
CERTIFICATE FROM THE NEW YORK STATE BUREAU OF EMERGENCY  
MEDICAL SERVICES.**

**WHEREAS**, the Town of Brunswick is a municipal corporation and a political subdivision of the State of New York under Town Law; and

**WHEREAS**, the provision of ambulance and emergency medical services to the residents of the Town of Brunswick is an appropriate matter for concern and deliberation by the Town Board of the Town of Brunswick; and

**WHEREAS**, in consultation with existing EMS providers and in view of the current EMS resources available in the Town of Brunswick, as well as the expectation that limitations on existing providers will persist into the foreseeable future; and

**WHEREAS**, the Town of Brunswick recognizes the value and benefit that the provision of consistent and reliable 24-hours-per-day, 7-days-per-week ambulance and advanced life support coverage provides to the health and safety of the citizens of and visitors to the Town of Brunswick; and

**WHEREAS**, after careful deliberation, the Town Board of the Town of Brunswick has determined that “public need” – as that term is defined by the Department of Health Bureau of EMS – for ambulance and emergency medical services exists within the Town of Brunswick; and

**WHEREAS**, in furtherance of the authority and obligations conferred upon the Town Board of the Town of Brunswick, the Town has determined that the current status as well as pending changes to the ambulance and emergency medical services within the Town’s geographical boundaries establishes the public need and necessitates this Resolution; and

**WHEREAS**, the Town of Brunswick is eligible to apply for a two-year municipal certificate of need (Muni-CON) pursuant to Public Health Law § 3008 (7)(a), which authorizes the Town of Brunswick to establish and operate an ambulance service for the benefit of the residents of the Town of Brunswick; and

**WHEREAS**, the Town Board of the Town of Brunswick has determined that it is in the public interest for the Town of Brunswick to apply for a Muni-CON and to provide for municipal operating authority for ambulance pursuant to Public Health Law § 3008 (7)(b); and

**WHEREAS**, the geographic area to be served pursuant to the Muni-CON is the entirety of the Town of Brunswick; and

**WHEREAS**, pursuant to General Municipal Law 122-b, the Town may provide for ambulance services in a variety of different ways which the Town Board wishes to consider;

**NOW THEREFORE,**

**BE IT RESOLVED**, that the Town Board, as the governing body of the Town of Brunswick, does hereby declare that "public need" exists for the provision of ambulance services in the Town of Brunswick; and

**BE IT FURTHER RESOLVED**, that the Town Board authorizes the submission of an application on behalf of the Town of Brunswick for a Muni-CON to the New York State Department of Health, Bureau of Emergency Medical Services; and,

**BE IT FURTHER RESOLVED**, that the Town Board authorizes the Town Supervisor or his designee(s) to prepare and execute such documents as may be necessary to assist and to effect the Town of Brunswick's efforts to establish and provide for the provision of ambulance services through the issuance of a Muni-CON, and when necessary, to obtain permanent operating authority on behalf of the Town of Brunswick.

**RESOLUTION NO. 26, 2025**

**RESOLUTION AUTHORIZING THE SUPERVISOR TO PURCHASE ROCK SALT FOR ROAD MAINTENANCE ON AN EMERGENCY BASIS, WITHOUT COMPETITIVE BIDDING, PURSUANT TO THE PROVISIONS OF GENERAL MUNICIPAL LAW SECTION 103(4)**

**WHEREAS**, the Town obtains rock salt for road maintenance from a central contract through New York State Office of General Services (OGS), which in turn receives its supplies from a company known as American Rock Salt; and

**WHEREAS**, the Town has been notified by OGS that American Rock Salt has been unable to meet its contractual obligations to OGS, and OGS has suggested that the Town may need to obtain rock salt from an alternative provider; and

**WHEREAS**, General Municipal Law Section 103(4) provides that in a public emergency arising out of an accident or other unforeseen occurrence or condition, when circumstances affecting public health, safety or property requires immediate action which cannot await competitive bidding, the appropriate officer of the political subdivision may contract for the purchase of supplies without going through competitive bidding;

**NOW, THEREFORE, BE IT**

**RESOLVED**, that the Town Supervisor is authorized to enter into a contract or agreement with an alternative provider of rock salt, in the event rock salt is not available through the OGS contract.

**RESOLVED**, that the Town Supervisor is hereby authorized to enter into an agreement with Spectrum for a sixty month contract, as set forth in their proposal.
