# TOWN OF BRUNSWICK PUBLIC HEARING JANUARY 14, 2021 6:30 p.m. TOWN HALL

Board Members Present: Supervisor Herrington, Councilman Christian, Councilman Sullivan, Councilman Balistreri and Councilman Cipperly
Board Members Absent: None.
Also Present: Attorney, Andrew Gilchrist and Town Clerk, William J. Lewis.

Supervisor Herrington called the meeting to order at 6:30 p.m.

The purpose of the meeting was to hold a Public Hearing to accept public comment on the proposed Introductory Local Law #3 of the year 2020 entitled "A Local Law Amending Local Law No. 1 of the Year 1988 Entitled "A Local Law Setting Speed Limits on Town Highways and County Highways Within the Boundaries of the Town Of Brunswick, Rensselaer County, New York"."

Supervisor Herrington asked Town Clerk Lewis to read the complete Notice of Public Hearing into the record. The Notice had been posted on the Town Website, Town Hall bulletin board and published in The Record.

Supervisor Herrington opened the Public Hearing.

### VISITORS WHO WISH TO SPEAK:

Jennifer Mann, 91 Hill Road, commended the Town for proposing this change and asked if there were any discussions about having a 4 way stop at Freer Park Road, North Lake Avenue and Genesee Street? Supervisor Herrington advised her that Rensselaer County had hired a Traffic Engineer to study that option and was told they were close to finishing up and will be making a recommendation soon. He decided to go ahead and at least take care of the speed limit in the meantime. Ms. Mann mentioned the issue of heavy traffic and speeding on the side roads in that area, perhaps as people try to avoid Route 7. She asked about the possibility of speed bumps being installed. Councilman Balistreri offered that speed bumps were a real issue with snowplowing.

Maureen Brier, 148 North Lake Avenue, believed the speed limit was 25 mph from Westlane Road to Frear Park Road, and felt a 4 way stop wouldn't help as the main problem was enforcement. Supervisor Herrington said he has reached out about enforcement. Ms. Brier has also seen drivers turning right from Frear Park Road go around people waiting to take a left, using the park lawn, and shooting right onto North Lake. She said there used to be guardrails along the exit from the park and maybe they should be reinstalled to prevent this. Councilman Sullivan inquired if a digital radar speed limit sign had ever been used on North Lake Avenue. Ms. Brier said there had been last spring, but it was set up closer to Liberty Road. Supervisor Herrington was informed by the County that there were plans to repave North Lake Avenue, which will include signage and marking changes. The down side is nicer roads often tempt people to go faster. Hopefully not.

# **VISITORS WHO WISH TO SPEAK:**

Zack Metzger, 3842 NY Route 2, has been to several meetings at Town Hall and thanked the Town for taking the pandemic seriously and following all the recommended precautions to keep attendees safe. With endless media/social media speculation recently about "rigged elections" including some about local ones, he asked the Board Members how they stood on the issue. Without exception, all the Board Members stated that they had never personally heard from anyone claiming unfair elections at the Town level or witnessed any improprieties. Supervisor Herrington felt that workers representing all parties have always been involved and diligent in their duties during elections, while working to get the vote out and as inspectors at the polling locations. He also commented that he felt the violence at the Washington demonstrations was disgusting, uncalled for and those responsible for the rioting should be prosecuted. Violence is not the answer to anything.

The issue is not uncommon around the Capital District. Mr. Herrington contacted Social Services and was informed that many programs were available for food and shelter and other assistance if the parties were willing to reach out and accept the help. He plans to speak to the people and give them the information. Attorney Cioffi noted that any ordinances/laws to address this type of problem would have to consider the constitutional rights of the people involved.
